

Information on Privacy Policy

Please be aware that by use of the website of MoD Mapping Co. (www.topomap.hu) and by supplying your personal data, you signify your assent to your personal information to be used to the necessary extent and for the necessary length of time, in accordance with Act 63 of 1992 on the Protection of Personal Information and the Publicity of Information of General Interest (hereinafter the Act).

Personal Information (Paragraph 1 of Article 2 of the Act: data by which an individual can be identified) may be collected by MoD Mapping Co in the following forms or instances:

- technical data generated during the course of the internet connection;
- data you supply when registering to our website or signing up to our newsletter;
- when you buy products in the virtual shop (online);
- when you contact us (via email, regular mail or phone).

Use of collected data (Paragraph 4/a of Article 2 of the Act): During the course of any visit to www.topomap.hu the authorized user of your Personal Information is MoD Mapping Co.

The technical data generated in our central computer system on establishing the internet connection are solely used to ensure access to the website services.

Visitors registering to the website by entering their details in the fields requested supply their personal information voluntarily. Their personal information will be transferred to our central database. Those who sign up to our newsletter will regularly receive notification on our latest publications and products via email or regular mail.

When you submit your answers to online public opinion surveys that are conducted on our website from time to time (as required), your answers will be recorded as statistical data in a way that does not include any identifiable personal information.

Data processing (Paragraph 4/b of Article 2 of the Act): No outside organization (data processing team) is engaged in the operation of the website and the management of Clients' data.

Data transfer (Paragraph 5 of Article 2 of the Act): MoD Mapping Co. does not transfer personal information that it collects to third parties.

Disclosure of data (Paragraph 6 of Article 2 of the Act): MoD Mapping Co. does not disclose or allow access to the personal information it obtains.

General Statement of Privacy Policy When using personal data and in the course of its activities related to data management, MoD Mapping Co. acts in accordance with Act 63 of 1992 on the Protection of Personal Information and the Publicity of Information of General Interest, guided by the data protection practice adopted in the course of the activity of the Data Protection Supervisor of Hungary, observing current legislation and adhering to relevant international recommendations related to privacy policy.

MoD Mapping Co. only uses the personal information of its Clients - to the extent and for the length of time necessary for the realization of the purpose of data management - which is essential and appropriate for the realization of the purpose of data management.

MoD Mapping Co. assures its Clients of complying with the law designed to protect Clients' privacy. (Paragraph 1 of Article 10 of the Act). Further, it will update, correct or delete Clients' personal information on Clients' request submitted in a written form (Paragraph 1 of Article 14 of the Act).

This statement pertains to the protection of our Clients' personal information that is not intended for the public. This statement does not apply to personal information that a Client voluntarily discloses in part or in full.
